## CATEGORIES

There are four grades of Membership Services who are entitled to use the following titles:

a)	Honorary Fellow	: HFMTCG
b)	Fellow	: FMTCG
c)	Member	: MMTCG
d)	Student	: MMTCG

## ELIGIBILITY CRITERIA

### HONORARY FELLOW

MTC Global confers Honorary Fellowship on eminent persons. No applications are called for this category.

### FELLOW MEMBER

To become eligible, he/she must have the following qualifications:

1. Applicant should already be MTC Global member or his/her organization should be a member for at least one year.
2. Person applying should currently be associated with an organization / company or association.
3. Applicant should possess outstanding and extraordinary qualification and experience and should be at senior position and responsibility. Also, should be the authority to whom people reports or the authority to whom applicant reports is sufficiently high in the organization.
4. Have attained distinction in one of the following ways:
  - Planning or operation or strategy related work activities.
  - Teaching a major course in an academic discipline at a premium management institution.
  - Expounding useful theories, principles or methods of management.
5. The person should have wide knowledge or expertise in the field of education and should have made a significant contribution to advancing the knowledge.

6. Applicant should be holding a prominent position that can have a positive impact on MTC Global's overall activities.

7. Recommended by at least two renowned persons / MTC Global Members.

8. Should be one of the following:

- Management Professional as President / Chairman / Director- Head of the Institutions / Chief Executive / Vice President / General Manager in Public / Private Sector Enterprises / Senior Management of SME's.
- Senior Public Administrative Official not less than Joint Secretary in the Government of India or equivalent.
- Defence Services official of the rank of Brigadier or equivalent and above.
- Academician of Professor Grade in recognized educational institutions of high standard.
- Technical or Legal Professional / Chartered Accountant / Cost & Works Accountant / Company Secretary.

9. Fellowships also depend on Designation, Qualification, Organization Turnover, Contribution to Education Development and Special Observations.

10. MTC Fellowship is limited preferably to 15 per year, but in any case maximum of 20 in a year.

### **MEMBER GRADE**

This grade is applicable to academicians, corporate executives and individuals from other walks of life having interest in education.

### **MEMBERSHIP-RIGHTS AND PRIVILEGES**

1. Every member will enjoy all rights and privileges of the association in accordance with the provision the Bye-laws as defined by MTC Global. These rights and privileges will be non transferable by his / her own act or by operation of law.

2. Once membership subscription is taken, the fees cannot be refunded at any case. MTC Global has only life membership subscription.

3. Every member will be entitled to use the membership titles by placing it after his / her name in abbreviated form, stated in accordance with his / her grade or membership, namely, HFMTTC, FMTC, and MMTC.

4. Every member will be entitled to receive a Membership certificate bearing registration number and date.

5. Members will get considerable discount in all programs conducted by MTC Global.

6. Members can publish paper in MTC Global Journal, contribute paper in our Edited Books and also eligible to apply for the award.
